

# The BalanceTrack “Stay on Track” Summer Sweepstakes

## OFFICIAL SWEEPSTAKES RULES

### *NO PURCHASE NECESSARY TO ENTER OR WIN*

- 1. Eligibility:** The BalanceTrack Stay on Track Summer Sweepstakes (the “Promotion”) is open only to legal residents of the 50 United States and the District of Columbia who are 13 years of age or older and located in the United States at the time of entry. Employees, contractors, directors and officers of BALANCE (“Sponsor”), BALANCE Marketing Department (“Judging Agency”) and their respective parents, subsidiaries and affiliated companies, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion (collectively, “Promotion Parties”), and their immediate family members (parent, child, sibling and spouse of each) and those living in the same households of each, are not eligible to enter the Promotion. Void elsewhere and where prohibited by law.

  - Users must complete at least one BalanceTrack module with a passing grade during the contest period (multiple entries across different modules are encouraged!).
  - Each month, we’ll randomly choose a user who’s successfully completed our Module of the Month, and award them a \$100 Amazon gift card.
  - Users can earn three bonus entries for successfully completing the Module of the Month.

Alternative entries must be received prior to the end of the promotion period.
- 4. Consent and Agreement:** By submitting an entry, you’re signifying your consent and agreement to abide by these Official Sweepstakes Rules.

The entry must exclude trademarks and slogans. The entry cannot be obscene, indecent, offensive, violent, hateful, or be against federal, state or local laws, as determined solely by the Sponsor. All decisions of the Sponsor are final.
